DIRECTIONS FOR USE

Pellet 3-IA contains IBA and vitamin B1 to stimulate root development and encourage growth in most species of plants and trees. The container application table is for treatment of nursery stock and plant material with PELLETT 3-IA ONLY. If using Pellet 3-IA with fertilizer in a container, please see "To use Pellet 3-IA for mixing with granular fertilizer" below. The product may also be blended with planting media, soils and other agricultural amendments.

Other uses for Pellet 3-IA are:

- 🌱 Fertilization amendment for growers, installers and general maintenance
- 🌱 Soil amendment for growers, installers and general maintenance
- 🌱 Deep root feeding
- 🌱 Hydro mulching for growers
- 🌱 Hydro seeding to assist in erosion control

TO USE PELLET 3-IA ONLY FOR:

Mixing with Granular Fertilizer

- 🌱 Blend 5% by weight with granular fertilizer

Mixing with Soil or Planting Media

- 🌱 Blend 0.4 lbs per yd³ of planting media (2.5 lbs per 6 yd³)

Sod or Crop Application

- 🌱 Use 0.625 lbs per 1,000 ft² when laying new sod
- 🌱 Use 28 lbs per acre when mixing in crop beds
